




#### TYPICAL UPPER FLOOR PLAN




#### FIRST FLOOR PLAN




#### TENTH FLOOR - SPACE PLANNING - HIGH

#### RENEWABLE ENERGY

Central Square is the first UK office building to utilise a LOW CARBON SYNGAS CHP (Combined Heat & Power) Unit which will generate the total hot water demand and provide electricity to the building.



#### **EFFICIENCY OF OCCUPATION**

The size, flexibility & efficiency of the floorplates are designed to accommodate occupational densities up to 1:10 sq m but this can be enhanced to 1:6 sq m.




#### Central Square is a two minute walk from Leeds Train Station
